Under the bill as passed no state loses a representative, and the following make gains: Illinois, New York and Texas, three each; Minnesota, New Jersey and Pennsylvania, two each, and Arkansas, California, Colorado, Connecticut, Florida, Louisiana, Massachusetts, Mississippi, Missouri, North Carolina, North Dakota, Washington, West Virginia and Wisconsin, one each. The bill provides that whenever a new state is admitted the representative assigned to it shall be in addition to the number provided in the bill. It also adds a provision never hitherto incorporated in a reapportionment bill, to the effect that congressional districts, in addition to being "contiguous," shall also be "compact." Army Canteen. Washington, Jan. 9.—The senate had under consideration the much-mooted canteen question, in connection with the army reorganization bill. The senate committee in effect restored the provision for a post exchange or canteen, which had been stricken out of the bill by the house. For nearly five hours the senate discussed the committee amendment. Senator Gallinger (N. H.) and Hansbrough (N. D.) vigorously opposed the amendment, and in turn, it was quite as strenuously supported by Senators Sewell (N. J.), Hawley (Conn.), Money (Miss.) and Carter (Mon Y

The senate committee on military affairs agreed to accept in modified form the amendment to the army bill suggested by Senator Hoar for the appointment of a commission to investigate the effect of the army canteen.

May Meet In Washington. Washington, Jan. 9.- The negotiations which have been pending for some time relative to the removal from Peking of some of the subjects of international negotiations so that they could be taken up at Washington or at the capital of one of the other powers have now advanced to a stage where there is promise of a satisfactory understanding among the powers on this move. It is the purpose to assemble an international commission which could pass on all questions of indemnity, both among themselves and as against China. It would be in the main a conference among the powers, although it is expected that Chinese envoys would be invited to participate after the proceedings reach a stage where unity of action among the powers was assured.

Situation In Venezuela.

Washington, Jan. 9 .- The last advices received by the state department from Minlster Loomis in Venezuela gave the situation there a more hopeful aspect. The minister has cabled that the revolution led by Perraza now appears to be completely suppressed. Mr. Loomis gives no details, but it is taken from this that the Casro government has been able to dispose of the uprising headed by Perraza.

Chicago, Jan. 9 .- Bound by an ironclad agreement of allegiance, the seven baseball clubs assured of a place in the American league circuit have turned over to President Ban Johnson. to be held in trust, 51 per cent of their capital stock. With this deposit comes the ground leases and options on the clubs' entire baseball property at a stated price in the event of a desire to sell. President Johnson returned from Cleveland and Detroit with this information. The move is a precautionary measure to put the league on a war

Are Devastating European Ports.

EFFORTS AT RESCUE PROVE FUTILE.

Wind Blowing a Hurricane aud Lash ing the Sea Into Fury - Live Intelligence of the Old World.

Marseilles, Jan. 9 .- A terrible disasfrom Oran, which stranded on the coast near the village of Faraman during a violent storm, with 50 passengers and a crew of 40 on board. She has heeled to the starboard and the waves are sweeping over her. Desby life boats and steam tugs have been made, but thus far the rough seas have prevented every effort to approach her. The wind is still blowing a hurricane, with no signs of abatement. The latest dispatch from the lighthouse keeper at Faraman describes the position of the steamer as hopeless. It is probable that the vessel and all on board will perish.

Great Critain Willing.

Londor, . 3 .-- Mr. Choate had an interview legalding the Chinese situation with Lord Lansdowne at the foreign office. The discussion was confined to the difficulties of the powers in agreeing to China's answer to their demands, which will necessitate a further negotiation. Great Britain has not yet replied to the circular of the United States government inviting the powers to confer in Washington, but she is willing to agree to the proposal. British officials generally are disheartened over the latest muddles in Peking and fear that a long time will elapse before matters are made straight.

Wonderful Submarine Boat.

Paris, Jan. 9.—The Figaro describes a voyage of two hours in the submarine boat Morse during the trials at Cherbourg Monday. "In less than two minutes," it says, "the ves 1 reached a depth of 18 feet, where her evolutions with ease and perfect safety. By means of an ingenious instrument, the periscope, floating inviseverything above was visible. The problem of the supply of air has been solved satisfactorily, and the crew were able to remain submerged for 16 hours without fatigue of the lungs."

The White Feather. London, Jan. 9 .- The case of Major General Sir Henry Colville, whose resignation was asked by the war office owing to the Lindley affair, has been left in the hands of Lord Roberts. Much additional evidence has been received, upon which the request for the resignation was based. Various high officers who have recently returned from South Africa assert that General Colville on several occasions took precautions for the safety of himself and his men which verged dangerously near to showing the white feather.

France and Belgium.

Brussels, Jan. 9.-The Belgian minister of foreign affairs, M. De Favereaux denies that he has received at any time from the Belgian minister at Paris, Baron d'Anehan, a report that General Zurlinden, when French minister of war in 1897, proposed to the superior war council that France should annex Belgium, as was asserted here by The Petit Bleu, on the alleged authority of M. DeLantchierer, former president of the chamber of deputies.

To Return In the Spring.

Paris, Jan. 9. - Archbishop Favier, the head of the French mission in north China, who reached Marseilles Jan. 5, has arrived in Paris. In an interview he said he believed the dowager empress would return to Peking in the spring, when order will be completely restored. Bank In an Ohio Village Looted of Thousands of Dollars.

Mansfield, O., Jan. 9.-Investigation shows that the robbery of David Ozier's bank at Shiloh was done by four men who came from Cleveland at midnight. They stole two horses and buggies from Jacob Gilger near the village and broke open the bank with tools secured from the Big Four section building. Railroad Catastrophe.

Fairmont, W. Va., Jan. 9 .- A collision between a freight train and a light engine on the Monongahela division of the Baltimore and Ohio railroad brought death to eight, fatal injuries to one man and slight injuries to two others. The collision occurred on the bridge crossing the mouth of Keen's ter threatens the mail steamer Russie run, which is 25 feet above the backwater of the Monongahela river. Orphan Asylum Fire.

Rochester, N. Y., Jan. 9 .- Twenty eight dead bodies lie at the morgue and 12 others more or less seriously injured lie at the different hospitals in the city as a result of the terrible holocaust which occurred early Tuesday morning at the Rochester Orphan asylum. Of the dead 26 were children of both sexes, ranging in age from 2 to 14 years, while the remaining two were adults, a nurse and a cook. The fire was doubtless caused by an explosion of gas in the boiler room adjoining the west wing of the asylum, and spread so rapidly many of the 109 inmates of the institution were overcome by the flames and smoke almost without warning.

China Will Accept.

Peking, Jan. 9. - Eleven protocols, representing each of the powers, were handed to the Chinese envoys for signature and for the affixing of the imperial seal. As the formality of communicating with the court is a necessary preliminary to using the seal, a delay of a few days is expected, but there is no reason to fear that the Chinese will fail to complete the acceptance of the note.

New York, Jan. 9.—The grand jury reported to Judge Cowing, handing up indictments against Clinton Marshall, J. R. Dean and Eugene Davis, the Bellevue nurses, for manslaughter in the first degree, in the killing of Louis Hilliard. After Hilliard's death it was found that several of his ribs were broken, and it was alleged that he received his injuries in Bellevue hospital.

Chicago, Jan. 9.-William J. Bryan was the guest of honor at the annual banquet of the Chicago Bryan league, at the Sherman House. Mayor Harrison acted as toastmaster. Mr. Bryan in the course of his speech remarked that he intends to continue actively in the discussion of public questions, and does not desire to be embarrassed by being placed in the attitude of a candidate for any office. Discussing the mooted subject of reorganization of the Democratic party, he said that reorganization is an internal remedy and one that can not be applied externally; a person must be inside of the party before he can participate in the party management. Defeat, said he, should not discourage those who believe in the principles set forth in the Kansas City platform: the battle must continue; but if fate decrees a change in the ideals of this nation, Democracy's struggle will inspire the lovers of liberty in future years. War Revenue Reduction.

Sympathy For Filipinos. Jefferson, Mo., Jan. 9.—By a vote of 75 to 47 the house adopted a resolution expressing sympathy with the Filipinos in their struggle for liberty. Several Democrats abstained from voting. Representative Prairera of St. Louis declared that no man should vote for such a "treasonable" resolution.

Burglar's Bloody Work.

Vienna, Jan. 9 .- A burglar named Wanyet, who had robbed a tenement on the Wilandstrasse, shot a woman dead whom he met as he was leaving. Pursued by the crowd, he shot five others dead, and he was not arrested until his revolver had been emptied.

Vernon was the man she wanted. As this Akron man was a member of the Congregational church of Akron, then just looking for a successor to Rev. Dr. Carlos Smith, who had given notice that his pastorate, begun Dec. 30, 1861, would terminate with March, 1873, he naturally inquired further, with the result of a report upon his return very favorable to Mr. Monroe. The latter was the more commended by the very excellent impression that his brother, Prof. James Monroe, had just made in this community by his first canvass for congress in this district. Consequently the Akron congregation desired the Mt. Vernon pastor to come here, but neither for Akron nor Chigago, nor any other place seeking his services, would he preach a trial sermon. The committee one Sunday sent one of its members, (Mr. Henry Perkins) to Mt. Vernon to hear Mr. Monroe, and his report confirming the good words about Rev. Thomas Edward Monroe, the church and congrega tion joined in a call that was accepted, and the pistorate begun the first Sunday in April, 1873, has lasted without a break until now. Last Sunday morning, Dec. 16, at the close of the morning service, Mr. W. G. Pitkin, as clerk of the trustees, read a very tender letter to the church from Dr. Monroe, offering his resignation, but delaying its taking effect until next September to allow ample opportunity to secure a successor, that the church work may not be interrupted. This follows the excellent precedent set by Dr. Smith, and makes the two pastorates continuous for practically 40 years, a fact unusual, but full of beauty and


