And by doing fealty and Suit of fourt from three Weeks to three Weeks if thereto required And by performing all fustoms and other Services that are due from other Justomary Tenants of the said Maymor And by paying on every Death and Surrender aswell for an Hariot as for a fine Sixpince each of certain And the said Henry Stearns are present in Court was Admitted Jenant of the said Premises according to the said Grant and had Seizin and botsession thereof by the Rod and paid to the Lord for a fine present as appears in the fourt Rolls and he did to the Lord fealty.
