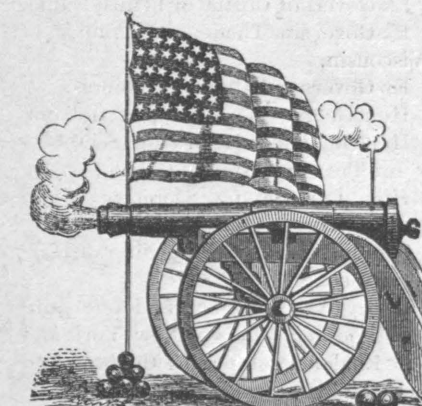

Governor Cleveland's Magnificent Reception at Buffalo.

Governor Cleveland visited his home in Buffalo, N. Y., on Thursday, for the first time, we believe, since he was inaugurated Governor, on which occasion he received the grandest ovation that ever was witnessed in this country, from his old friends and neighbors. A dispatch states that the procession occupied two hours and ten minutes in passing the Genesee House. There were over twenty thousand voters in line and over a hundred choirs, with more brass bands than that, and hovering at least eight miles of streets. The parade was witnessed by at least fifty thousand more people. The streets were a livid sea of fire, the smoke of the powder and the glare of the pyrotechnics prevented the eye from seeing a distance. Governor Cleveland delivered a brief but eloquent address, which was received with vociferous applause. Several other gentlemen also spoke.
