Washington, Feb. 15 .-- Count Cassini, the Russian ambassador, presented the president a magnificent album containing scenes of the coronation of the czar in 1896. The album is a present and souvenir from the czar to President McKinley, and was made especially for the latter. The front of the album has medallion portraits in gold of the Russian ruler and his wife.

#### Treasury Statement.

Washington, Feb. 15.-Statement of the treasury balances in the general fund, exclusive of the \$150,000,000 gold reserve in the division of redemption: Available cash balance, \$143,903,650; jold, \$75,987,849.

#### Louisville's Liberality.

Louisville, Feb. 15 .- The Louisville city council appropriated \$20,000 towards the entertainment of Knights emplars at the triennial conclave here next August. This is independ ent of the \$100,000 being raised by the local members of the order to provide a program of attractions for grand encampment week. It is understood the city council will later add to its subscription \$10,000 for illumination, out of which sum will be erected a massive electric quadruple arch at the intersection of Fourth and Jefferson streets, to cost \$7,000.

Washington, Feb. 15. - The senate devoted most of the day to the agricultural appropriation bill, Mr. Hale (Me.) and Mr. Lodge (Mass.) sounded notes of warning against the enor mous appropriations being made by the present congress. Mr. Hale ge clared the people of the conary soon would become alarmed, and then those who were responsible for the immense expenditures would seek the rocks and mountains to hide from the wrath of the people. Mr. Lodge declared that the expenditures of the government. as shown by the appropriations, were approaching rapidly the billion-dollar mark, and he believed it was time now to draw the line

During the discussion of the bill Mr. Pettigrew claimed that there are now 10,000 sick and disabled American soldiers in the Philippines. Mr. Hale acceded to this statement and added that in five years every man in the Philippines would be on the pension list. Mr. Sewell (N. J.) declared these statements were untrue. Mr. Teller (Colo.) supported Mr. Pettigrew's statement, and the latter declared his belief that the number of sick and disabled soldiers in the Philippines would aggregate 40,000 a year for years to come, or so long as the war might last.
