BLUBAUGH DELINQUENT

Three Alternates Will Take Places Of Colored Men Here

A general shake-up in the list of men to go to Camp Sherman on April 26 has taken place at the office of the local board on account of word that no colored selects will go to camp with the next quota having been received here, and the delinquency of William Henry Blubaugh of Jelloway, who is reported as missing.

The order concerning the colored selects excludes three men who were to go to camp in this call. They are Clarence Simmons Sites, Cooper Jackson and Clyde Franklin Turner.

The exclusion of the three colored men places the following three alternates on the list to go to Camp Sherman: James G. Beal, Jesse M. Larimore and William Lawrence Wills. However, Wills will not go to camp if a card is received from the commanding officer over Howard Judy, who comes in this call, but is already in the military service. If William Henry Blubaugh does not appear between now and April 26, it will put Charles C. Breckler in the running on the regular list of selects, the board has announced.
