

controversy, it is not unlikely that diplomatic relations between Great Britain and Russia will become strained almost to the breaking point. Possibly British warships may be dispatched to bring pressure to bear upon Russia, but war will not result unless some fracas, quite unexpected at London and St. Petersburg, occurs between the opposing forces at Tien Tsip.

This assertion is based upon exhaustive inquiries. A prominent British official, often the mouthpiece of the government, said: "It is useless for our newspapers to use provocative language. They forget that we have a great army in South Africa and that we have no other army, nor the mak ings of one elsewhere. It is impossible to go to war with Russia."

A semi-official statement has been issued to the effect that the much talked-of assurances of the Russian foreign minister, Count Lamsdorff, to Sir Charles Stewart Scott, Britten and bassador at St. Petersburg, were mad Feb. 6. and evidently referred to the Russo-Chinese agreement concluded at Port Arthur last November, and not to the Manchurian convention. It is understood that one official view is that

Albany, March 19. - Assemblyman Price introduced a bill to enable New York city to accept the offer of Andrew Carnegie to give \$5,200,000 for public library purposes. The bill authorizes the city to receive donations of money, sites, buildings, books or property and to enter into agreements with the donors or their legal representatives. The city is also authorized to acquire sites to any extension for a public library system made necessary by donations or bequests.

Means a New Treaty.

Berlin, March 19 .- A day's sensation has been caused by an article sent to Germany through the Russian semiofficial telegraph agency by M. De Witte, Russian minister of finance. Various interpretations are placed upon it. One is that M. De Witte now declares that he was not responsible for the personal attacks upon Count Von Buelow in the article, which appeared in the St. Petersburg Trade and Industry Gazette. Cossacks Attacked. London, March 19 .- Dispatches from St. Petersburg describe fierce fighting between the demonstrators and the Cossacks. The latter charged the men at a gallop and the people replied with volleys of stones. A Cossack officer who was struck on the head by an iron bolt was unhorsed. The Cossacks, on seeing their leader fall, dismounted and engaged in a hand-to-hand fight. using their whips freely on the people. many of whom were injured seriously,

although nobody was killed. Altogether 800 students were arrested.

No Agreement Reached.

Terre Haute, Ind., March 19. - No joint conference was held by the miners and operators, but the miners devoted a greater part of the session to the adoption of the revised district constitution, which has been prepared to conform with the constitution of the national body. No agreement has been reached by the scale committees of the operators, and miners, and at present it is doubtful whether the work of settling the wage question will be decided before Friday.

South African Situation. London, March 19 .- Lord Roberts,

in a letter to a correspondent, expresses a confident hope that Lord Kitchener will soon be able to secure peace in South Africa, but thus far there is no sign from Pretoria or Cape Town that peace is near. The latest news is that General Fourie, with 800 men, escaped Sunday from the British columns that were endeavoring to corner the commando east of Bloemfontein. Further big operations will be started in Orange River Colony within a few days.
