BANNER STORY CAUSE OF MUCH COMMENT

Judge F. O. Levering's Stock Transaction Greatly In- terests Readers

Publication of the story touching
recent negotiations for the property
of the Knox T. & R. Co., particularly
the episode of Judge F. O. Levering's
stock transaction, carried exclusively
in The Banner last Saturday, appears
to have been the cause of not a little
comment.

The generality of this comment is
in agreement with the opinion expres...
ed which, while not charging ulterior
or improper motives to the gentlemen
who visited Mt. Vernon last week,
holds, nevertheless, their propositions,
if accepted, would have been profitab...
le only to themselves or their com...
pany and not to the stockholders or
creditors of the Knox Tire & Rub...
ber Co.

J. Frank Turner, who is a member
of the firm conducting a pool room in
the basement of the building at the
corner of West High street and the
square, Monday informed the Banner
he had been disappointed in not meet...
ing J. G. Feist while here. Unlike
Judge Levering, his stock dealings in
the concerns in which Mr. Feist had
been interested had been wholly sat...
isfactory. In 1918, Mr. Turner said,
he had acquired 60 shares of stock
of the National Rubber Co. Subseq...
uently this was merged into the Na...
tional Rubber Products Co. and still
later into the Hydro-United Tire Co.
For his original 60 shares he received
25 shares of the Hydro-United com...
pany. This holding has been increas...
ed by stock dividends of 25 shares, and
he has been notified of an additional
dividend coming Oct. 10.

Mr. Turner says he has received
each month checks covering his div...
dends in the Hydro-United Co.
