Your Certificate of Identification No. 7656814 is being for-warded to you at your present address. This address differs from the one appearing on the Certificate and indicates that you have moved without properly notifying the Alien Registration Division and the Federal Bureau of Investigation.

Section 10(a) of the Regulations Governing Certificates of Identification for Aliens of Enemy Nationalities states as follows:

> "Whenever the holder of a Certificate of Identification changes his (a) name, under legal authority, (b) residence address, or (c) place of employment, written notices thereof shall immediately be given to (1) the Alien Registration Division of the Immigration and Naturalization Service, and (2) the Federal Bureau of Investigation."

Section 13(a) further states:

"Any alien of enemy nationality herein defined who fails to comply with these regulations or any other regulations governing the conduct of aliens of enemy nationalities, is subject to apprehension, detention, and internment for the duration of the war."

A Change of Address Card, Form AR-11, is enclosed, which is to be filled and forwarded to this Division. A written statement indicating the change of address must also be forwarded to the local office of the Federal Bureau of Investigation, which is indicated at the bottom of the first page of the Certificate of Identification.

Your immediate attention in this matter is required.

CURRENCY, TO COVER TAX REQUIRED BY THE UNITED STATES FOR ALIENS IN ACCORDANCE WITH "AN ACT TO REGULATE THE IMMIGRATION OF ALIENS INTO THE UNITED STATES" AND ISLAND POSSESSIONS, EFFECTIVE MAY 1, 1917.

NOTICE TO PASSENGERS

The ALIEN HEAD TAX represented by this receipt is collected for account of the United States Government, and is paid by this Company to the United States Government, As a rule, the U. S. Bureau of Immigration will refund this tax, through the Steamship Company, in cases in which the following conditions are shown:

1. That ALIEN'S regular domicile or bona fide residence was in Canada, Newfoundland, Cuba or Mexico, for at least one year prior to entry into the United Stated coming for a temporary stay.

2. That ALIEN has been in transit through the United States and its possessions and has left within sixty days. Aliens of this class must:

(a) Be listed as "Transits" by Immigration officials on their arrival. Passengers who do not state at time of arrival their intention to remain but sixty days, cannot obtain any refund, even though subsequently leaving the United States within that period.

(b) They must on arrival at U. S. port secure a certificate (Goy, Form 514) from the Immigration Officials.

(c) The certificate with this receipt and passenger's permanent address should be forwarded to the American President Lines, at the port where tax is paid by the Steamship Company to the U. S. Government as soon as possible, as claim must be filed with the United States Government within ninety days after alien's arrival at U.S. port where taxed.

NOTE: Should any transit passenger lay over between the port of embarkation and the U. S. port, he must secure an endersement to that effect on this receipt, by the Purser of the steamer on which he arrives at the U.S. port, showing the name of such such steamer and the date of arrival.

PURSERS AND AGENTS:

Pursers and Agents should be careful to ascertain if aliens in transit are in possession of through transportation, and if so, note form number and destination on Alien Manfest.
