Additional descriptive comments on figurative or decorative portion of the exterior:

This is a fragment of the body of a figurine, otherwise unidentifiable. It's curved, with a projection off of one end that has broken off. This appears to have been part of a hollow figurine, perhaps the same one as 202AF/023-1 and -2, since it's about the same color + paste, but it doesn't articulate with those pieces. This piece, like the others, is also smoke blackened, but only near the breaks.

The item is: not eroded - slightly - moderately - very - extremely eroded.
